



THE BULL TERRIER CLUB **CRITERIA FOR THE SELECTION OF JUDGES**

A1 LIST

For persons who have previously been approved by The Kennel Club Ltd to award C.C.'s in the breed and has completed their first appointment, and has the support of The Bull Terrier Club. (KC Policy).

A2LIST

For persons who fulfil all the requirements for the **A3** List and who have been assessed in accordance with The Kennel Club Ltd requirements and accepted by The Kennel Club Ltd for inclusion on the **A2** List and have the support of The Bull Terrier Club. (KC Policy).

A3 LIST (Breed Specialist)

A minimum of **7** years judging experience in the breed and have the full support of The Bull Terrier Club. (KC Policy).

To have judged at **3** Breed Club Open Shows. The Shows are to be at least 3 years apart.

To have Judge a minimum of **60** Breed Classes.

To have Judge a minimum of **70** Dogs (KC Policy).

To have attended a Seminar given by a Kennel Club Accredited Trainer and passed the relevant examination on KC Regulations and Judging Procedures. (KC Policy as at 01-07-2001).

To have attended at least one Breed Specific Seminar run in accordance with the relevant Kennel Club Code of Best Practice and passed an examination and/or assessment where applicable. (KC Policy as at 01-07-2001).

To have attended A Seminar given by a Kennel Club Accredited Trainer on Conformation and Movement. (KC Policy as at 01-07-2001)

To have bred and/or owned a minimum of **3** dogs when they obtained the **1st** entry in The Kennel Club Ltd Stud Book. (Save in exceptional circumstances) (KC Policy).

To have stewarded over a minimum period of **3** years and at **12** Shows (KC Policy).

Candidates should meet with the approval of The Bull Terrier Club Committee with regard to honesty, integrity and competence. Consistent ring etiquette, good behaviour and an attentive courteous manner are fundamental expectations in any Judge. Potential **A List Judges** are expected to uphold The Kennel Club Guidelines for Championship Judges regarding correct appearance and behaviour.

Judges should not be the centre of attention through garish or outlandish dress or through bizarre behaviour. Judges MUST NOT smoke whilst judging and alcoholic drinks are not to be taken into the ring.

The Bull Terrier Club Committee reserves the right to refuse any applicant.

A3 LIST (Non Specialist)

A minimum of **10** years judging experience in any one breed (to include 5 years in this breed) and have the support of The Bull Terrier Club (KC Policy).

To have judged a total number of **100** dogs.

To have judged at least **2** Club Shows the shows to be at least **3** years apart.

To have judged a minimum of **50** classes in the breed.

To have awarded CC's in at least one other breed. (KC Policy).

To have attended at least one breed specific judging seminar run in accordance with the relevant Code of Best Practice and passed an examination and/or assessment where applicable.

To have bred and/or owned **3** dogs of any breed when they obtained their 1st entry in The Kennel Club Ltd Stud Book. (save in exceptional circumstances).

Candidates should meet with the approval of The Bull Terrier Club Committee with regard to honesty, integrity and competence. Consistent ring etiquette, good behaviour and an attentive courteous manner are fundamental expectations of any Judge.

Potential **A List Judges** are expected to uphold The Kennel Club Ltd Guidelines for Championship Judges regarding correct appearance and behaviour.

Judges should not be the centre of attention through garish or outlandish dress or through bizarre behaviour. Judges MUST NOT smoke whilst judging and alcoholic drinks are not to be taken into the ring.

The Bull Terrier Club Committee reserves the right to refuse any applicant.

B LIST (Breed Specialist)

To have **5** years' experience owning and exhibiting in this breed and have the support of The Bull Terrier Club.

To have judged **6** Classes of this breed at Open Show or Championship Shows without CC's.

To have judged **10** dogs of this breed.

To have attended at least one Breed Specific Judging Seminar and passed an assessment where applicable.

The Bull Terrier Club Committee reserves the right to refuse any applicant.

B LIST (Non Breed Specialist)

A minimum of **7** years judging experience in any one breed and have the support of The Bull Terrier Club.

To have judged **28** classes of this breed at Open Show or Championship Shows without CC's.

To have judged **50** dogs of this breed.

To have attended two Breed Judging Seminars and passed an assessment where applicable.

The Bull Terrier Club Committee reserves the right to refuse any applicant.

C LIST (Breed Specialist)

For aspirant Judges who have shown an interest in the breed and have the support of The Bull Terrier Club.

The Bull Terrier Club Committee reserves the right to refuse any applicant.

C LIST (Non Breed Specialist)

For aspirant Judges who have shown an interest in the breed and have the support of The Bull Terrier Club.
